



Hall of Fame Nomination Guidelines

OVERVIEW:

The California Homebuilding Foundation invests in the future of homebuilding through scholarships, research, and education. The Foundation is the host of California's top industry award- The California Homebuilding Foundation Hall of Fame.

Hall of Fame, presented annually by the Foundation, was established to honor, and pay tribute to outstanding leaders in our industry, and to raise funds benefiting the Foundation's charitable mission in the areas of scholarships, research, and education.

For over 35 years, individuals have been recognized for their contributions that have resulted in the long-term advancement of homebuilding, construction, development, marketing, finance, or related services within the building industry in California.

This lifetime honored title grants no special rights, privileges, or duties. Hall of Fame awards do not carry any monetary value but serve to recognize and celebrate extraordinary contributions and support of the California homebuilding industry.

NOMINATION REQUIREMENTS

- ALL nominees must meet **ALL OF THE THREE MANDATORY CRITERIA REQUIREMENTS** listed below to be considered for induction into the homebuilding Hall of Fame
- Criteria is listed in the order of significance
- If a nominee does not meet all three criteria requirements, future consideration **WILL NOT BE GIVEN** to that individual until all criteria requirements are met
- Incomplete applications and / or omitted required attachments, will not be considered

NOMINATION CATEGORIES

1. **Builder)** Nominee must be or have been an owner, major principal or senior officer of a home building or development company operating in California
2. **Associate)** Nominee whose careers are or have been closely related to, contributed to, and clearly supportive of the homebuilding and development industry
3. **Other)** Individuals, including elected officials, who have clearly demonstrated their support of the homebuilding and development industry by their actions

Hall of Fame Nomination Guidelines

MANDATORY CRITERIA REQUIREMENTS

Nominees are evaluated on their achievements and leadership in these areas:

1. Career

- Success and reputation of a company they have created
- Pioneering or leading-edge work accomplished
- Influence in the marketplace

2. Industry involvement and participation - individual and/or company

- BIA/HBA volunteer service and key leadership role(s)
- CBIA/NAHB volunteer service and key leadership role(s)

3. Philanthropy, community involvement and support – individual and/or company

- History of philanthropic work and contributions
- Service and commitment to non-profit community organizations
- Outstanding achievements and awards

RESTRICTIONS

1. A candidate nominated from either the Builder or Associate category must be or have been a member of a local BIA / HBA or CBIA Association during their career
2. No individual may nominate more than one person each year, except when acting on behalf of their local association
3. Multiple nominations from one company in the same year are discouraged, not including extraordinary circumstances
4. Out-of-state nominees can be nominated only if their contributions during their active careers were California based

TIMELINE

AUGUST THROUGH OCTOBER:

- Call for Hall of Fame nominations are put forward to California Homebuilding Foundation Board of Trustees, CBIA Board members, Past Honorees, and BIA Association EO's
- Nomination applications will not be accepted from individuals. Hall of Fame nominations must be lead and submitted by one of the above listed groups
- California Homebuilding Foundation Executive Committee appoints the Hall of Fame Selection Committee

NOVEMBER 1ST:

- Hall of Fame nomination application submission deadline

NOVEMBER:

- Hall of Fame Selection Committee, inclusive of past Hall of Fame Honorees, receive proposed nominee applications for consideration
- Selection Committee meets to review and vote on proposed nominees
- Selection Committee's recommendations are submitted to California Homebuilding Foundation Board of Trustees for final vote to accept/deny slate of nominee as presented

TIMELINE, continued

DECEMBER:

- Recommendations confirmed and nominating parties notified of selected nominees
- Inductees notified and confirmed acceptance of nomination received by the California Homebuilding Foundation
- Press release assembled for January release
